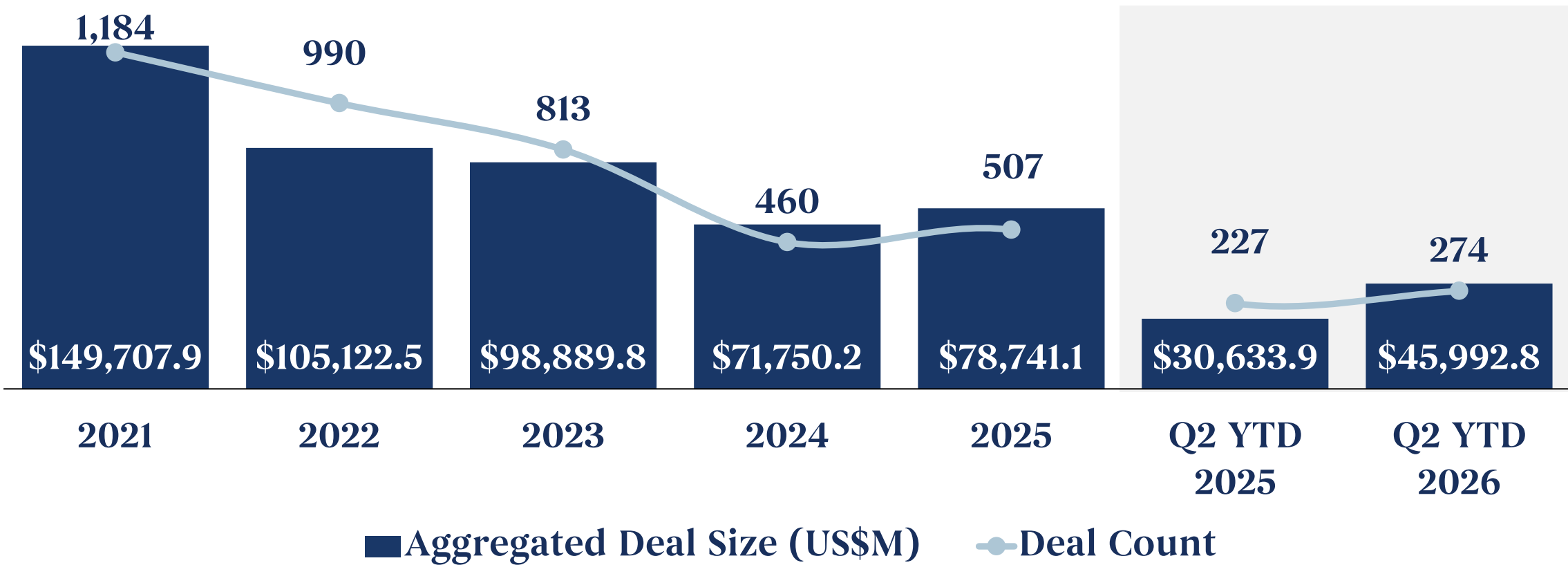

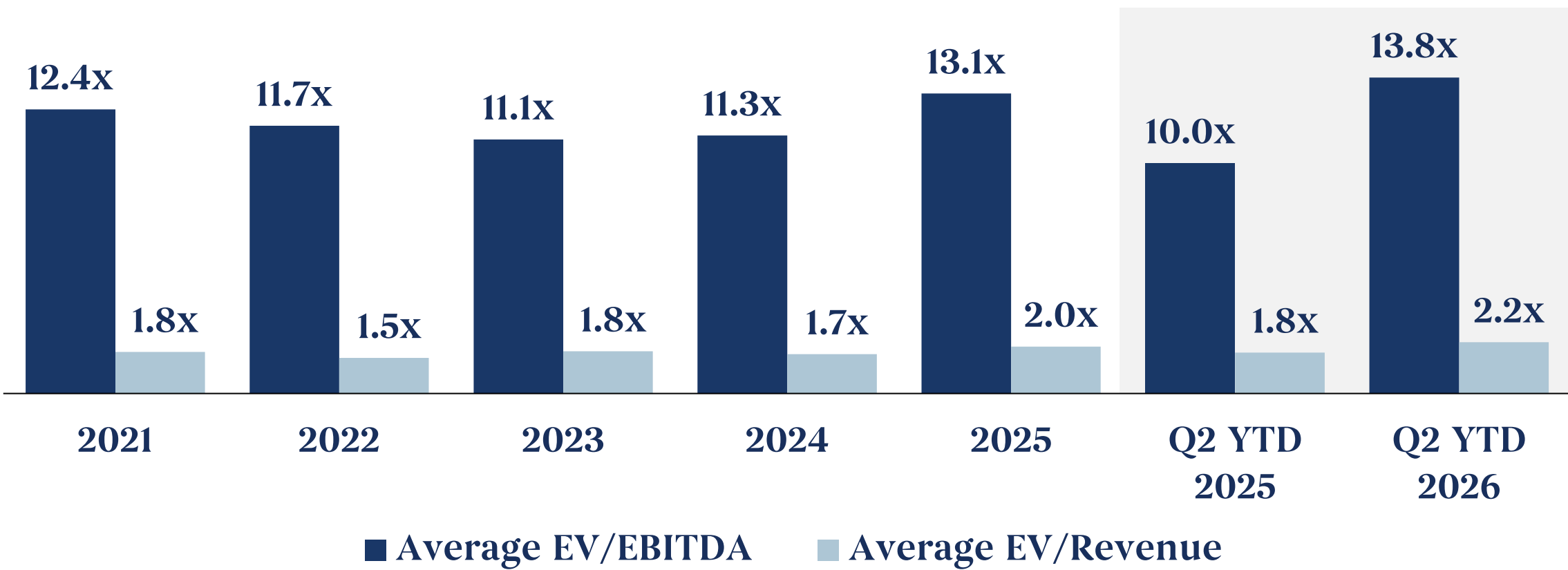
M&A Trends and Market Intelligence

- The **global HVAC system market** revenue was valued at approximately **US\$259.0B in 2025** and is projected to reach **US\$445.7B by 2033**, growing at a **CAGR of 7.0%** during the forecasted period
- **Market growth** continues to be driven by **increasing demand** for **energy-efficient buildings, smart infrastructure**, and **sustainable climate-control systems**, supported by stricter energy regulations and government incentive programs globally
- Growing integration of **IoT-enables monitoring, AI-driven optimization, smart thermostats**, and **advanced building automation systems** is transforming the industry and **improving energy efficiency, indoor air quality**, and **predictive maintenance capabilities**
- Increasing investments in **green buildings, data centers, healthcare infrastructure**, and **smart commercial facilities** continue to **support long-term industry growth**, alongside rising adoption of heat pumps, low-emission cooling technologies, and energy-efficient HVAC systems globally
- The HVAC equipment market has supported **active M&A activity**, driven by investments in **cooling technologies, advanced refrigerants**, and other innovations that enhance **energy efficiency** and meet the needs for data center, industrial, and commercial applications
- **Private buyers** continue to play a significant role in sector consolidation, pursuing acquisitions that offer **portfolio expansion, geographic reach**, and technology synergies, while public buyers have shown a more selective activity

The acquisition represents Beijer Ref’s entry into the North American market and will establish the company as a leading HVAC/R distributor in the U.S. South/South East region, one of the most attractive regions for HVACR in North America.

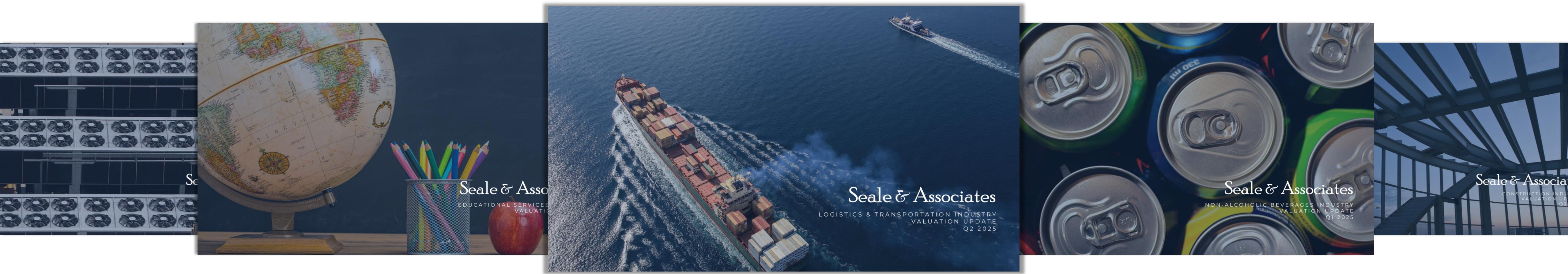

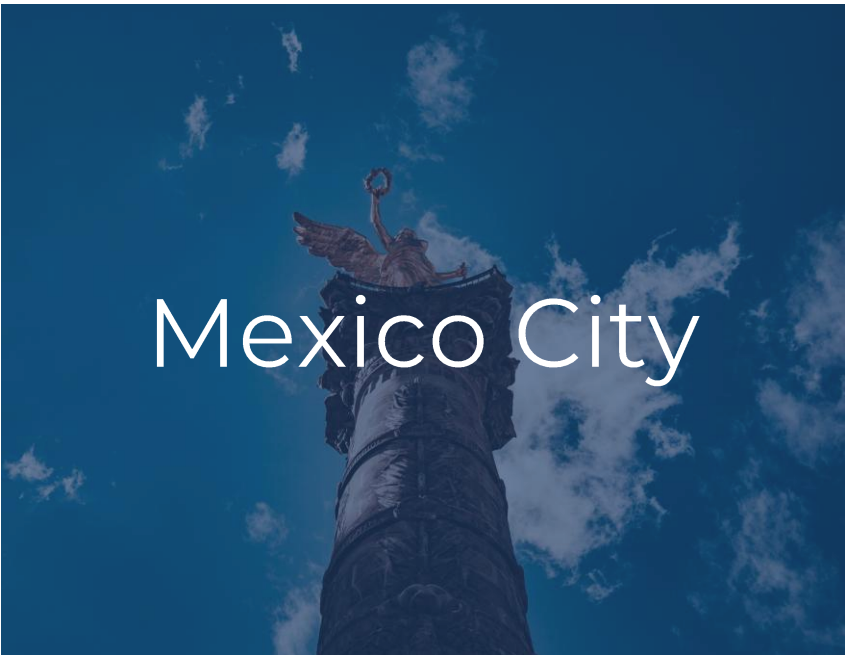
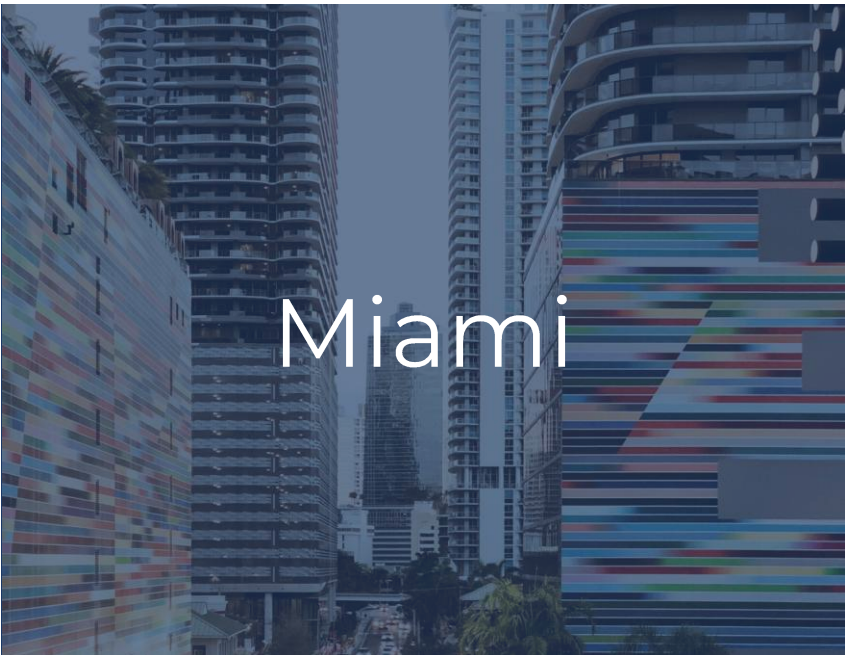
