


Disclosed Deal Volume in Mexico

Annual Transactions (US\$ million)




Summary of International Transactions by Mexican Companies


Disclosed Deal Volume by Mexican Companies in Foreign Geographies

Annual Transactions (US\$ million)





The **Mining** industry led the domestic M&A activity in Mexico, with **3 transactions** as of January 2026, representing **21.4%** of the total announced transactions.



The **Real Estate and Industrial** sectors led M&A activity by Mexican companies in foreign geographies, with **1 transaction each** as of January 2026, representing **50.0%** of the total transactions.






