


Summary of Mergers & Acquisitions in Colombia

Number of Transactions per Month



Accumulated Transactions Value (US\$ Million) | Number of Transactions




Summary of Transactions by Colombian Companies Abroad

Disclosed Deal Volume by Colombian Companies Abroad


Number of Transactions per Month

Disclosed Deal Volume and Value by Colombian Companies Abroad Accumulated Transactions Value (US\$ Million) | Number of Transactions




Summary of Mergers & Acquisitions by Industry

The **Industrial** sector leads the domestic M&A activity in Colombia, with **13 transactions** as of November 2025, representing **20.0%** of the total announced transactions.




